001 FP HCC 82

Commences at junction with North Lane W of Sarratt Mill bridge thence NW to county boundary (Bucks).

002 FP HCC 82

Commences at TQ 0353 9781 thence south east along the pumping station access road (to TQ 0356 9777) then turning eastwards to the river then generally south eastwards following the SW bank of the river Chess to TQ 0376 9761 where it extends part way across the river to join Sarratt Footpath 41 at TQ 0377 9762. Continuing from TQ 0376 9761 SE along SW side of River Chess past Power House thence SE past E boundary of Woodlands to junction with Solesbridge Lane SW of Soles Bridge.

Width Minimum 4m between TQ 0353 9781 and TQ 0376 9761 as shown hatched on the Plan forming part of the Hertfordshire County Council (Chorleywood 2) Public Path Diversion Order 2000. 2.13 (7') along the remainder of the path.

Limitations Between TQ 0353 9781 and TQ 0376 9761 the path may contain mature trees (provided that there is a 4m useable width). Locked gates across the route at TL 0354 9780 with a 0.9m gap to the south west.
