001 BR HCC 19

Commences from Icknield Way at parish boundary and junction with BR16 (Lilley) SW of Floodhole Plantation thence N to county road N of Mortgrove.

002 FP HCC 10
HCC 19

Commences from Hexton - Lilley Road at N corner of Fanny's Spinney thence SW and S along W edge of same to NW corner of Mortgrove Plantation thence S along W edge of same and E of Burwell Plantation thence W and S to join county road NE of Mortgrove.

003 BR HCC 19

Commences from County Boundary at SE corner of Belt Wood and junction with BR 3 Shillington (Beds.) thence S to junction with Icknield Way (BOAT 10 Hexton-BOAT 24 Lilley) and BR 9 Lilley at TL 1161 2878.

004 FP HCC 10

Commences from Hitchin - Hexton Road immediately W of county boundary thence N to join same on E side of Meg Cottages Fence.

Commences from Hexton - Higham Gobion Road immediately N of Cricket Ground thence NW to NE corner of spinney at county boundary and junction with FP5 (Higham Gobion).

Commences from county road approx. 170 yards N of Methodist Chapel thence N along E side of ditch for approx. 620 yards thence across ditch and NE along W side of same across Hexton Common to county boundary at foot-bridge SW of Apsleybury Wood.

Commences from FP6 approx. 240 yards S of northern parish boundary thence SW across Hexton Common to join Hexton - Higham Gobion Road E of Western parish boundary.

Commences from BR18 (Beds) at the county boundary thence NE along the Icknield Way to its junction with county road NW of Floodhole Plantation (scheduled also as BOAT 23 Lilley).

Commences from junction with Lilley-Hexton road at TL 1088 2825 thence NE for approx. 50m to the junction with BR 7 Lilley at TL 1093 2828, continuing NE for approx. 900m to the junction with BR 3 Hexton and BR 9 Lilley W of Telegraph Hill at TL 1161 2878, thence NE up Telegraph Hill for approximately 330m to a junction with BOAT 61 Shillington (Beds.) at the County Boundary, TL 1184 2894. This route is also known as BOAT 24 Lilley (part).
