Commences at junction with Restricted Byway 19 S of Hoo Wood thence N skirting W boundary of wood thence N and NE thence N again to county boundary (Bucks).

Commences at junction with county road opposite Ringshall Laundry thence generally SE through Ashridge Park across FP5 at Witchcraft Bottom thence SE and then NE to junction with county road opposite Memorial Lodge at Little Gaddesden.

Commences at junction with county road and FP2 opposite Ringshall Laundry thence generally SE through Ashridge Park to junction with FP5. Recommences from FP5 approx 170m SW of previous junction thence SE then S to west end of Ashridge House thence SW and SE along eastern boundary of Hardings Rookery to join Park Road at Berkhamsted Lodge.
