Commences at county road at sharp bend in road W of Tillers End at field-gate and keeping hedgerow and belt of trees on the right, proceed approx. 150 yards then bear sharp right through gap in hedge, continuing round the next field (cultivated to within 2 feet of hedge) for approx. 300 yards and through gap in hedge where well defined cart-track 8 feet wide continues (hedge now on left). After a further 250 yards through field-gate into meadow lane, where path continues direct to Cherry's Green Farm. Keeping to eastern side of main farm buildings, through old stack yard into road.
