THE HERTFORDSHIRE (ERMINE STREET, GOOSE GREEN)  
(PROHIBITION OF ENTRY AND DRIVING) ORDER 1989

The Hertfordshire County Council, in exercise of their powers under Sections 1(1), 2(1) to (3) and 3(2) of the Road Traffic Regulation Act 1984, and of all other enabling powers and after consultation with the Chief Officer of Police, in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

1. Save as provided in Article 4 of this Order, no person shall cause any vehicles over 1½ tonnes in weight unladen to enter or proceed at any time along that length of Ermine Street in the East Hertfordshire District specified in the Schedule to this Order.
2. Save as provided in Article 4 of this Order no person shall cause any vehicle with more than two wheels to enter or proceed along the length of road specified in the Schedule to this Order except at such times as the gates are left in an open position.
3. In accordance with Section 92 of the said Act of 1984, upon the coming into operation of this Order, locked gates and bollards will be placed on the road referred to in the Schedule to this Order so as to prevent the entry and passage of all motor vehicles, with more than two wheels except those referred to in Article 4 of this Order, for whom access will be made available by the issue of keys to unlock the said gates.
4. Nothing in Articles 1, 2 or 3 of this Order shall prevent any person from causing or permitting a vehicle to enter or proceed in the length of road referred to in that Article if the vehicle is being used:-
  - (a) with the permission of the Highway Authority in connection with any agricultural or building operation in or adjacent to that length of road the maintenance, improvement or reconstruction of that length of road, or laying, erection, alteration or repair in or adjacent to that length of road of any sewer or any main pipe or apparatus for the supply of gas, water, electricity or any telecommunications apparatus defined in paragraph 1(1) of the Telecommunications Code contained in Schedule 2 of the Telecommunications Act 1984;
  - (b) in the service of a local authority or statutory water undertaker or water authority in the pursuance of statutory powers or duties;

(c) for fire brigade, ambulance or police purposes

5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
6. This Order shall come into operation on the 14 day of May 1990 and may be cited as "The Hertfordshire (Ermine Street, Goose Green) (Prohibition of Entry and Driving) Order 1989".

SCHEDULE

That length of Ermine Street from Lord Street northwards to a point approximately 2 metres south of the vehicular access to Elbow Lane Farm a distance of approximately 770 metres.
