

NOTICE OF CONFIRMATION OF PUBLIC PATH DIVERSION ORDER

DACORUM BOROUGH COUNCIL

(FOOTPATH HEMEL HEMPSTEAD NO. 60)

PUBLIC PATH DIVERSION ORDER 1987

TOWN AND COUNTRY PLANNING ACT 1971 S.210

On 28 September 1987 the Dacorum Borough Council confirmed the above-named Order as an unopposed Order.

The effect of the Order, as confirmed, is to divert the public right of way running from Wood Lane (grid reference 0584-0683) northwards to Hillfield Road (0579-0712) to a line running from Wood Lane (0584-0683) north-westerly along the eastern boundary of Paradise to the hospital (0584-0683) thence through the hospital grounds to its junction with Hillfield Road (0579-0712) being a length of 550 metres and a minimum width of 2 metres.

The new path shall be provided for the use of pedestrian traffic only and shall not be used by horses and horseriders.

A copy of the Order and map contained in it has been deposited and may be inspected free of charge at the address below during normal office hours.

This Order became operative as from 28 September 1987, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained thereon on the ground that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any regulation made thereunder has not been complied with in relation to the confirmation of the Order he may, within six weeks of 2 October 1987 make an application for the purpose to the High Court.

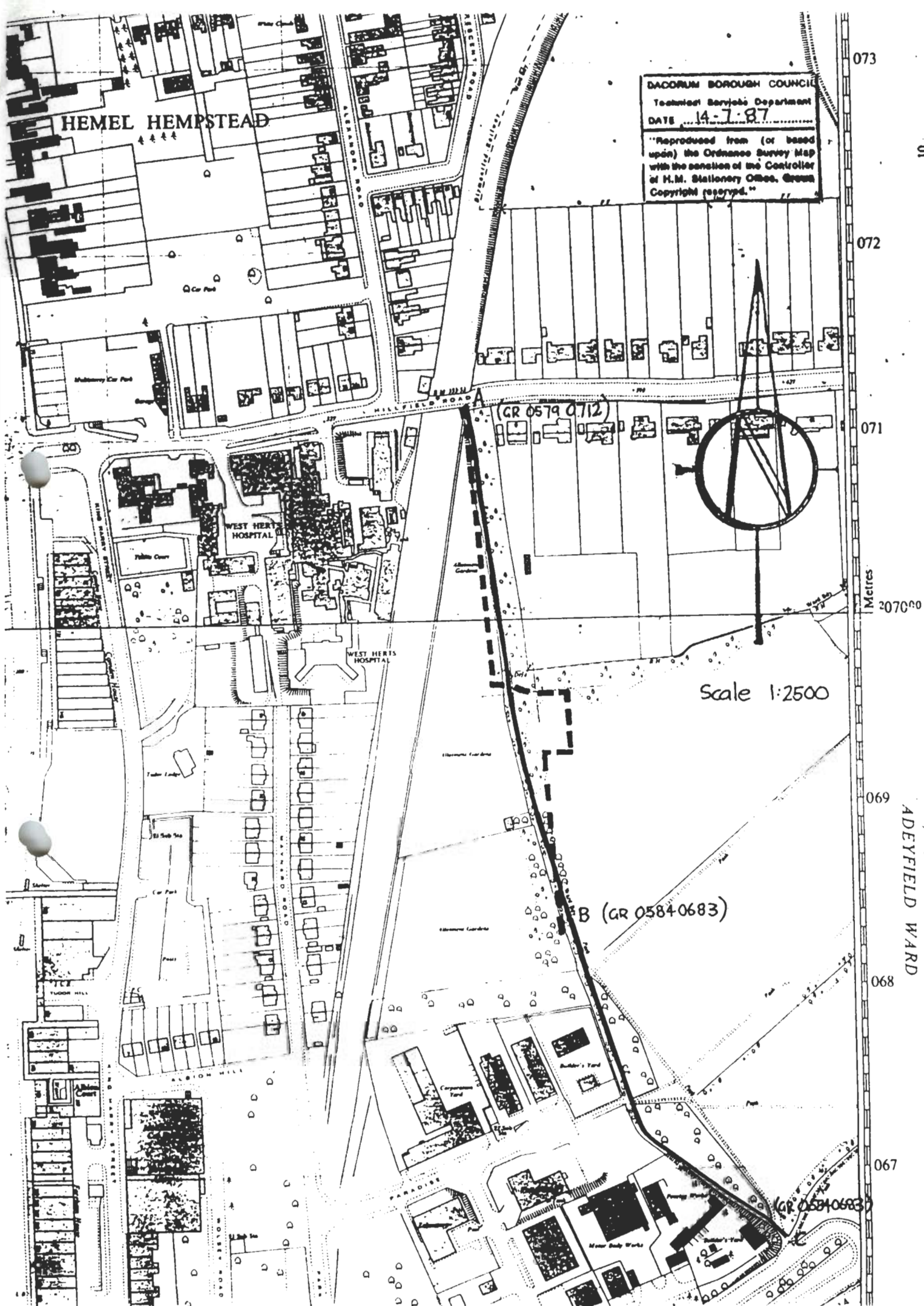

TRAFFIC REGULATION ORDER 1987

NOTICE IS HEREBY GIVEN that the Dacorum Borough Council pursuant to arrangements made under s. 101 of the Local Government Act 1972 with the County Council of Hertfordshire in exercise of the powers of the said County Council under s.1 of the Road Traffic Regulation Act 1984 propose to make an Order, the effect of which will be that:-

1. No person shall proceed along Footpath Hemel Hempstead No. 60 as described in the Schedule to this Notice.
2. No person shall drive, ride or cause to be driven or ridden any cycle, tricycle, motorcycle, motor vehicle or machine along Footpath Hemel Hempstead No. 60 as described in the Schedule to this Notice.

An alternative route for pedestrians will be provided and waymarked to connect Hillfield Road and Wood Lane, Hemel Hempstead.

DESCRIPTION OF FOOTPATH AS DEFINED BY
THE BOROUGH OF DACORUM (FOOTPATH HEMEL HEMPSTEAD NO. 60)
PUBLIC PATH DIVERSION ORDER 1987

Footpath No. 60 commences at Wood Lane at grid reference 0584-0683 and runs north-westerly along the eastern boundary of Paradise to the hospital at grid reference 0584-0683, thence through the hospital grounds to its junction with Hillfield Road at grid reference 0579-0712, being a length of 550 metres.

A copy of the proposed Order, an explanatory statement and a map showing the footpath concerned may be inspected during normal office hours at the Borough Secretary's Department at the address given below.

Any representations or objections to the proposal, stating the grounds on which they are made, should be sent in writing to the Borough Secretary no later than 30 October 1987.

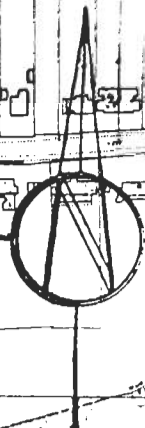
