NOTICE IS HEREBY GIVEN that the North Hertfordshire District Council, acting as agents for the Hertfordshire County Council, made the above named Order on the 23rd December, 1986 under Section 3 of the Cycle Tracks Act 1984 which is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed by the District Council as an unopposed Order.

The effect of the Order, if confirmed without modifications, will be to designate as a cycle track the length of footpath described in the Schedule. Both pedestrians and cyclists will have a right of way over this route but all motor vehicles including mopeds will be prohibited. The designation of this route as a cycle track will enable the District Council to undertake certain works to improve safety for pedestrians and cyclists.

A copy of the Order and other relevant documents may be inspected at the address below on Mondays to Fridays between 9 a.m. and 4.30 p.m.

Any objection to the Order should be sent to me in writing before the 30th January, 1987 and should state the grounds on which it is made.

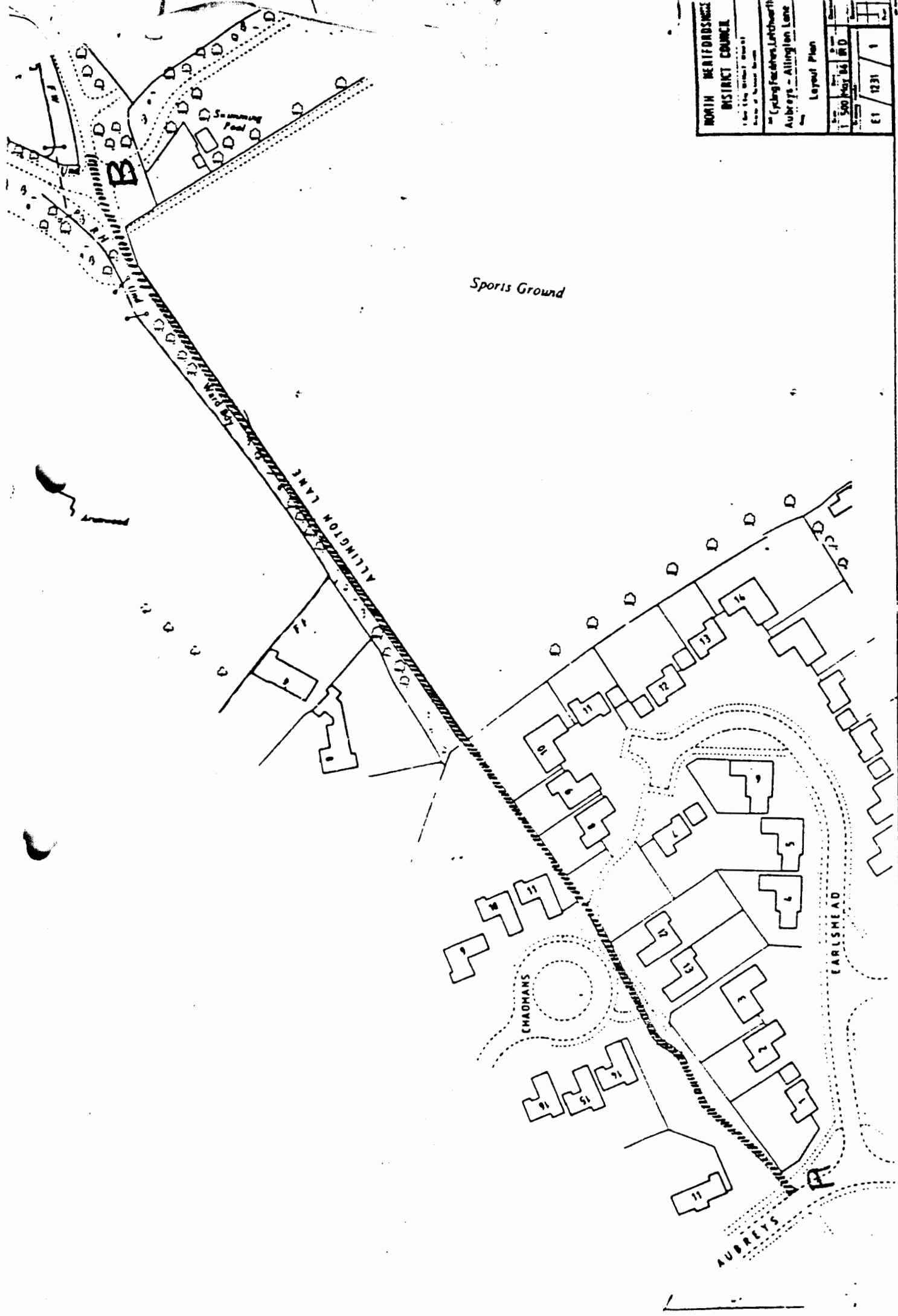

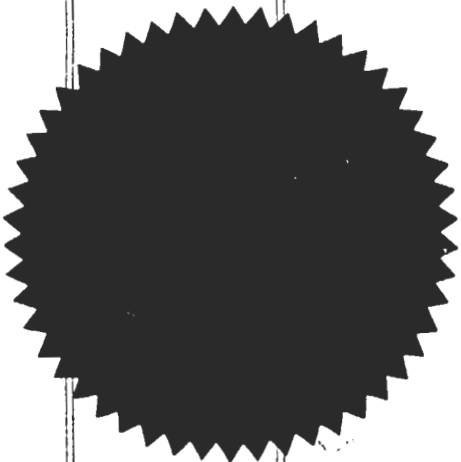
The North Hertfordshire District Council (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hertfordshire County Council, and in exercise of the powers conferred upon them by Section 3(1) of the Cycle Tracks Act 1984, having undertaken the consultations required by Regulation 3 of the Cycle Tracks Regulations 1984, hereby make the following Order:-

1. The footpath described in the Schedule to this Order and shown by zebra hatching on the annexed plan is hereby designated a cycle track.
2. This Order may be cited as the North Hertfordshire District Council (Part of Public Footpath No. 8, Letchworth) (Aubreys to Muddy Lane, Letchworth) Cycle Tracks Order 1986, and shall come into operation at the end of 28 days from the date on which notice of confirmation of this Order is first published.

SCHEDULE

The footpath designated a cycle track by this Order is that length of Footpath No. 8, Letchworth from the north western kerbline of Aubreys between the properties known as number 1 Earlsmead and number 11 Aubreys (approximately 15 metres north of the projection of the northern flank wall of 11 Aubreys) shown as Point A on the plan appended to the Order, running north-west for a distance of approximately 365 metres along the length of Alington Lane to its junction with Muddy Lane, shown as Point B on the plan appended to the Order.

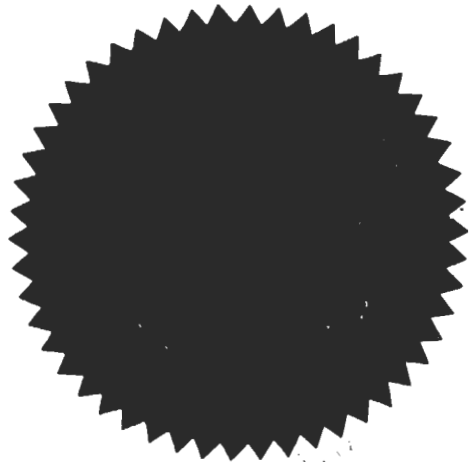

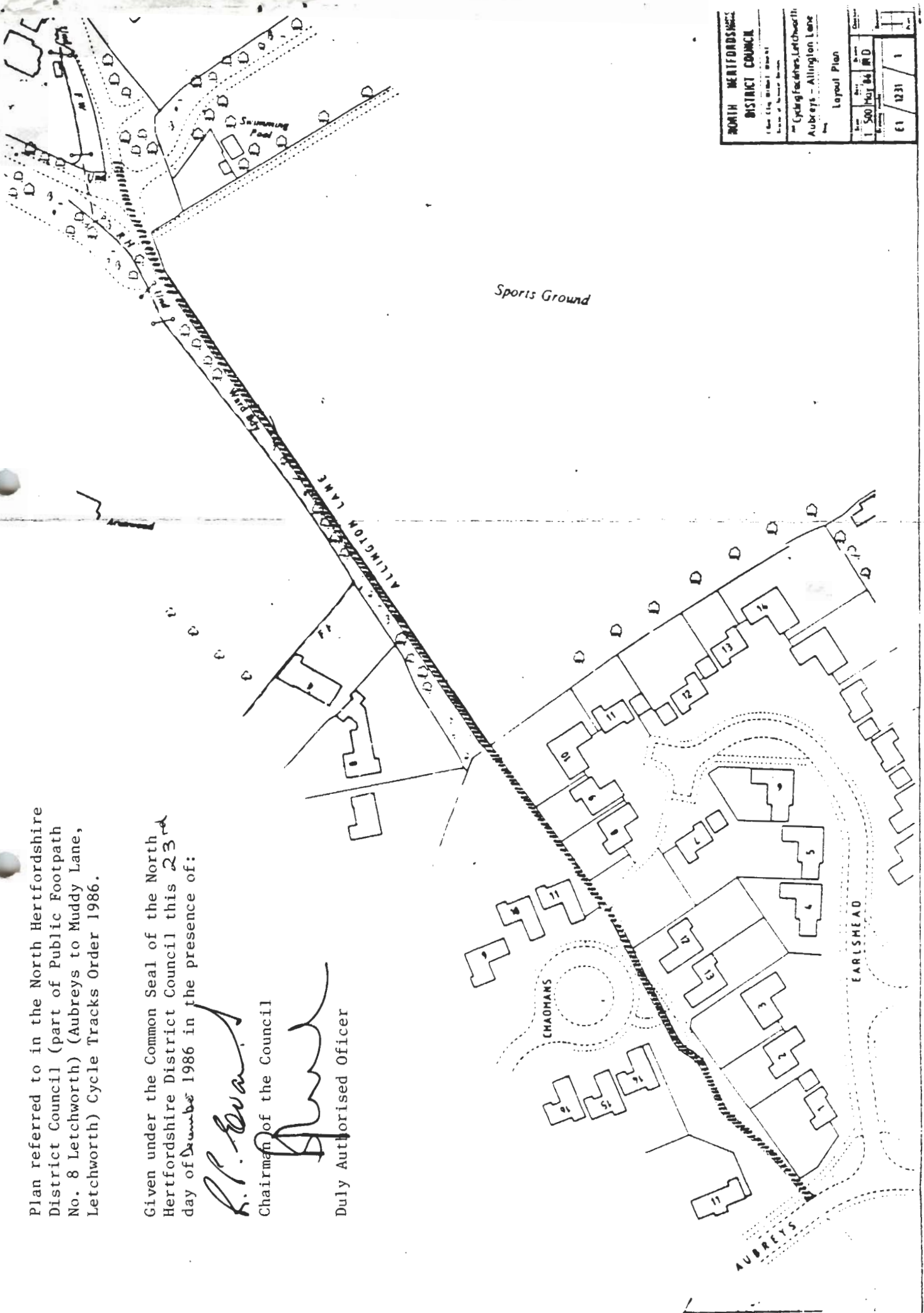

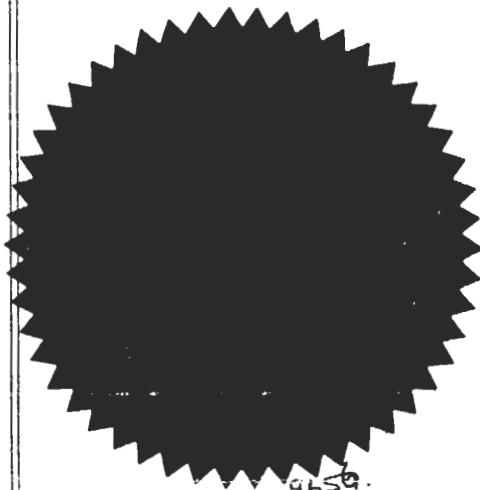

NOTICE IS HEREBY GIVEN that the NORTH HERTFORDSHIRE DISTRICT COUNCIL acting as Agents for the Hertfordshire County Council made an Order on 18th February 1988 under Sections 1 and 2 of the Road Traffic Regulation Act, 1984, the effect of which will be to close to pedestrians the lengths of Central Approach and Commerce Way, Letchworth referred to in the Schedule below during the times stated.

A copy of the Order which comes into effect on 31st March 1988 and a plan may be inspected at my office between 9.00 a.m. and 4.30 p.m. Monday to Friday.

Any person who desires to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1984, or on the grounds that any requirement of that Act, or any instrument made under it has not been complied with in relation to the Order may within six weeks of the date the Order was made, apply to the High Court for this purpose.
