ROAD TRAFFIC REGULATION ACT 1984

THE HERTSMERE BOROUGH COUNCIL (BLANCHE LANE, SOUTH MIMMS) (RESTRICTION OF DRIVING ORDER 1991

The Hertsmere Borough Council (hereinafter referred «co as "the Council") pursuant to arrangements made under SlOl Local Government Act 1972 with the County Council of Hertfordshire in exercise of the powers o the said County Council under Sl Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as 'the Act of 1984), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. Save as provided in Article 2 of this Order, no person shall cause any vehicle to proceed in the length of road specified in the Schedule to this Order.
- 2. Nothing in Article 1 shall prevent any vehicle proceeding in that length of road which is being used:-
 - (a) for the purposes of agriculture in connection with land adjacent to that length of road or for the conveyance of haulage of timber felled upon that land;
 - (b) in connection with: -
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said length of road; and
 - (iv) the laying, erection, alteration or repair in or in land adjacent to the said length of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Paragraph 1(1) of the Telecommunications Code contained in Schedule 2 to the Telecommunications Act 1984;
 - (c) for the purpose of delivering or collecting postal packets as defined in \$87 Post Office Act 1953;
 - (d) for Police, Fire Brigade or Ambulance purposes; and
 - (e) the service of a local authority or a water authority in the pursuance of statutory powers or duties.



- 3. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 4. This Order may be cited as the Hertsmere Borough Council (Blanche Lane, South Mimms) (Restriction of Driving) Order 1991 and shall come into operation on THE SECOND day of SEPTEMBER 1991.
