Objectives

It will also help provide enhanced education opportunities (with more flexibility to offer a broad curriculum for teaching and learning) and improved facilities in new buildings to enhance educational standards. St Joseph's Catholic Primary School has been successful in its bid under the Government's PSBP2, which means significant works to improve the school built environment_will be undertaken. As part of the planning for these works Hertfordshire County Council have been in discussions with the school and the Diocese of Westminster around expanding the school to 2 Forms of Entry (FE) from 1.5 FE, 1 FE is 30 places per year group, which would assist in meeting a local Catholic need.

Analysis of recent applications for primary school places in Bishop's Stortford indicates an unsatisfied demand for Catholic provision in the town.

Although forecasts indicate a surplus of places from 2017 onwards, for the three years 2014/15 to 2016/17 we have had to add an additional 1 FE of places in each year to meet actual demand despite the forecast indicating sufficient capacity.

We are aware of other new housing in Bishop's Stortford, particularly within the town centre which isn't taken account of in terms of additional provision proposed within Bishop's Stortford North and is also not included within the primary forecasts as they only project four years into the future. The forecasts will not therefore take account of the full impact of the yield from this new housing.

We take the following datasets into account within our forecasting methodology:

- 0-5 year olds registered with GPs
- primary pupils moving on to secondary schools
- trends, including migration to and from other authorities and the independent sector; and
- an assumed pupil yield from new or planned housing developments

The above table demonstrates that there is a basic need for the additional places to be created by this proposal as well as analysis of recent applications for primary school places in Bishop's Stortford which demonstrates an unsatisfied demand for Catholic provision in the town. The proposal therefore should not have a direct effect on other schools, academies and other educational institutions within the area, although the pattern of parental preference may change as a consequence of the new provision becoming available.

1. Purpose of report

- 1.1 To inform Cabinet of the outcome of the public consultation on proposals for the permanent expansion of the premises of primary schools in order to provide additional school places in September 2018 (PEP7), to meet a rising demand for them.
- 1.2 To enable Cabinet to decide whether to publish statutory proposals and to approve the capital costs of the schemes.

2. Summary

- 2.1 Overall there has not been a large response to the consultations, although more responses have been received on one proposal than the others, and the majority of respondents have been in favour of each of the proposals. All three governing bodies have agreed with the proposals.
- 2.2 Consideration of the issues and concerns relating to each proposal are contained in Appendices 1 3.

2.3 Cabinet is invited to:

- (i) reject the proposals,
- (ii) modify the proposals or
- (iii) authorise the Director of Children's Services to publish statutory notices to enlarge the premises of the schools in question by the size and date identified,
- (iv) to approve the capital costs of the individual schemes.

4.3 The Panel also endorsed the Director of Children's Services initiating consultation on the proposals where appropriate.

5. The outcome of public consultation on the proposals.

Process and timescale

- 5.1 The County Council's public consultation on relevant proposals started on 26 January 2017 and finished on 16 March 2017. This was over a seven week consultation period.
- 5.2 A similar consultation letter to that, attached at Appendix 4, was sent to all parents, governors and staff of every school affected, as well as all schools in the area, and to all other statutory consultees. Letters were also sent to:
 - residents local to the schools:
 - MPs, County Councillors, District Councillors, Parish and Town Councils and Local Authority Chief Executives;
 - Trade Union representatives;
 - Church Diocese representatives;
 - NHS representatives:
 - Further Education establishments, pre-schools, playgroups, children's centres, toddler groups and day nurseries;
 - Libraries and Citizen's Advice Bureaux.

The letter and response form were also available on the County Council's Hertfordshire.gov.uk website. Posters were also sent for display during the consultation period to children's centres, toddler groups, preschools and playgroups, day nurseries, libraries, citizen advice bureaux, doctor's surgeries, supermarkets, and coffee shops/cafes local to the schools involved.

Responses to the consultations

- 5.3 A total of 197 written responses have been received to all the consultations. Copies of all responses received are available to Members in the Members' Lounge.
- 5.4 A detailed analysis of the response for each school is attached in Appendices 1–3, each of which will include:
 - a breakdown of the number of responses received, and who they are from;
 - an analysis of the key issues raised and the response to them;
 - a copy of the governing body's response; and
 - an officer conclusion and recommendation.
- 5.5 Overall, there has not been a large response to the consultations, although more responses have been received on one proposal than the others, and the majority of respondents to each proposal has been in favour of the proposals, as indicated in the following summary table. All

three governing bodies have agreed with the proposals.

- 5.6 Overall, there were positive comments about the proposals, welcoming the provision of additional local places. Analysis of all the responses identified the most concern over traffic congestion/parking, which is common to many school expansion schemes. Assessments of highways issues will be included in town planning applications which will be subject to separate consultation. Any decision to enlarge a school would be conditional upon the receipt of town planning consent, where necessary.
- 5.7 These and other issues raised are included in the relevant appendices.

6. Financial Implications

Revenue funding

6.1 Revenue funding has been made available to support the feasibility work for the school expansion programme.

Capital funding

6.2 The total estimated cost of the PEP7 permanent expansion programme at this stage is £3.15m following initial scheme design and development. The estimates for Millfield and St. Catherine's are based on the value engineered tender costs of previous PEP programmes, but reflect an anticipated market position. The variances in costs reflect site specific issues, the replacement of existing mobiles and the extent of external works required. The estimate for St. Joseph's is from the Education Funding Agency as Hertfordshire County Council's contribution to its larger re-building scheme.

6.3 Since the previous report to Cabinet, additional allocations of basic need grant has been received from Central Government. The updated summary financial position, reviewing funds available from grants, approved section 106, less existing commitments, is:

Funds currently available up to 2017/18: £31.624m

PEP7 £ 3.15m

Allocation remaining: £ 27.474m

- 6.4 The allocation remaining will need to be used for any newly emerging primary needs for 2018/19 and for 2019/20 and a second secondary expansion programme to start from 2019/20.
- 6.5 It should be noted that there are signs of market recovery and tender returns will reflect this, but current costs have been assessed on the emerging market conditions.
- 6.6 Approval is therefore sought to the costs of the permanent PEP7 schemes as identified in para 6.2 above.

7. Equalities

7.1 When considering proposals placed before Members it is important that they are fully aware of, and have themselves rigorously considered the Equality implications of the decision that they are making.

- 7.2 Rigorous consideration will ensure that proper appreciation of any potential impact of that decision on the County Council's statutory obligations under the Public Sector Equality Duty. As a minimum this requires decision makers to read and carefully consider the content of any Equalities Impact Assessment (EqIA) produced by officers.
- 7.3 The Equality Act 2010 requires the County Council when exercising its functions to have due regard to the need to (a) eliminate discrimination, harassment, victimisation and other conduct prohibited under the Act; (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it and (c) foster good relations between persons who share a relevant protected characteristic and persons who do not share it. The protected characteristics under the Equality Act 2010 are age; disability; gender reassignment; marriage and civil partnership; pregnancy and maternity; race; religion and belief, sex and sexual orientation.
- 7.4 Equalities Impact Assessments (EqIAs) have been carried out and updated where necessary on all proposed school expansions contained within this report at Appendix 5. They have been made available in the Members' Lounge prior to Cabinet, in order that Members are fully aware of any equality issues arising from the proposals. Consideration has been given to the likely impact of the proposals, and current assessments conclude that it is not anticipated that people with protected characteristics will be affected disproportionately. The EqIAs will continue to be reviewed and updated as necessary.
- 7.5 The Local Authority is bound by the Admissions Code and Regulations and this does not allow for any discrimination in this respect.
- 7.6 The expansion of school premises will enable additional school places to be made available as close as possible to the demand for them. This will improve access to school places for all sectors of the communities in which they are located, and avoid very young children having to travel longer distances to access education.
- 7.7 The expansion of existing schools provides for enhanced education opportunities and an enriched curriculum offer which has a positive impact on the whole school community.
- 7.8 School expansion schemes provide positive impacts, offering the opportunity for improved facilities for disabled access in new buildings.

8. Conclusions and Next Steps

8.1 There continues to be a real and pressing need to provide primary school places in some areas of Hertfordshire. Not providing the premises to allow additional places to be offered will mean that very

- young children may be forced to access places some considerable distance from their homes.
- 8.2 There has not been a large response to the proposals, although there were more responses on the proposal for one school than the others. The key issues raised by respondents have been answered and can continue to be worked on through the next stages of the process.
- 8.3 Subject to Cabinet's agreement to the recommendations at item 3, if no objections are received to a statutory proposal, the Director of Children's Services has delegated authority to approve it. Where objections are received, the final decision will be referred back to Cabinet in its role as the statutory decision maker for Hertfordshire.

ST JOSEPH'S CATHOLIC PRIMARY SCHOOL: PROPOSAL TO ENLARGE THE PREMISES by 0.5f.e. from 2018

1. Response to the consultation.

1.1 A total of 141 responses were received to the consultation of which 110 were in agreement with the proposal and 26 disagreed. A breakdown of the responses is shown below:

- 1.2 The Governing body agrees with the expansion to 2 forms of entry. A copy of the governing body response is shown at the bottom of this appendix
- 1.3 Copies of every response received are available in the Members Room to enable Members to review the detail prior to the Education Panel and Cabinet meetings.

2 Key issues raised

- 2.1 The majority of respondents (78%) supported the proposal to expand St Joseph's Catholic Primary School highlighting the need for more places locally, and agreeing that the expansion offers opportunities for the educational improvement of this OFSTED outstanding school.
- 2.2 Around 30% of respondents acknowledged the need for additional primary places in the town for now and the future and commented that the increase of St Joseph's by 0.5fe would assist in easing the current issues round oversubscription. Around 9% of respondents also highlighted how the proposal would enable the school to operate in straight year groups rather than mixed aged classes as it does currently.

2.2.1 The following key issues were raised and a response to them provided below.

The enlargement will lead to increased levels of traffic and associated parking (including staff parking), road safety and congestion problems (52 respondents)

Over a third of respondents raised the issue of increased levels of traffic and highways issues as a key concern.

An independent highways assessment carried out at the initial feasibility stage has indicated that whilst there are challenges, provided mitigation measures are put in place, the highways network could cope sufficiently with the additional journeys that result from this proposed expansion.

The physical enlargement scheme and any associated traffic measures, including on site car parking, will be the subject of a separate town planning process which will be led by the Education Funding Agency. A detailed transport assessment and any required measures to mitigate the impact of additional traffic will form part of this town planning application, and a part of this process will be a formal consultation with the local community and the highways authority.

Officers are also working with the school to proactively promote safe and sustainable travel to school as part of the school travel plan, as well as ensuring the school travel plan takes account of the additional pupils that would result from the proposed expansion. The school travel plan will include a commitment to ensuring parents are encouraged to park safely and considerately in the surrounding areas thereby minimising inconvenience to local residents and other road users.

Additional places will go to non-local children & why expand a single religious denomination? (3 respondents)

A small number of respondents (2%) were concerned that the additional places would not meet a local need due to the school's admissions rules and questioned why a faith school was being expanded.

Analysis of recent applications for primary school places in Bishop's Stortford indicates an unsatisfied demand for Catholic provision in the town. This unmet demand is from the local community. The enlargement of the school will assist in meeting both the increase in demand for school places locally and the unsatisfied demand for Catholic provision in the town.

St Joseph's Catholic Primary School is well located to meet this demand and prioritises places based on practicing Catholics for admission allocation purposes. Whilst the admissions rules do not prioritise places based on distance, latest analysis indicates there is unsatisfied catholic demand in the town and therefore the provision of additional places will assist in meeting this demand

As well as the key issues outlined above, one respondent raised a concern that there was insufficient information provided by the council to enable consultees to make an informed decision and one raised a concern around the need for additional places in light of current forecast. A further comment was raised that the school site is not large enough to accommodate the proposed enlargement, and one raised a concern that the expansion would have an adverse environmental impact.

Issues which were raised by only one respondent each included the potential adverse environmental impact; insufficient information provided; and the site not being large enough.

3. Conclusions and recommendations

- 3.1 The majority of respondents agreed with the proposal to enlarge St Joseph's Catholic Primary School. The most common concern related to increased traffic congestion and car parking. The major issues raised have been carefully considered and responded to both here and in the body of the main report.
- 3.2 Having analysed all responses, it is the Officers' view that in light of;
 - the agreement of the Governing Body to the expansion; and
 - the fact that St. Joseph's Catholic Primary School is well located to meet the additional demand;

the enlargement of St. Joseph's Catholic Primary School is the right solution to provide the additional 0.5f.e. school places needed in Bishop's Stortford from 2018/19.

- 3.3 Issues such as the impact on the highways network and specific proposals for building the additional accommodation required for the school to expand will be the subject of a future town planning application which will involve formal consultation with local residents and the school community. Any school enlargement decision will be conditional upon the granting of town planning permission for the building scheme proposals.
- 3.4 It is therefore recommended that Cabinet authorise the publication of a statutory notice to enlarge the premises of the school from 2018/19.

Governing Body Response:

Chair of Governors: "On behalf of the Governing Body at St. Joseph's Catholic Primary, I would like to express our delight that after decades of trying to increase the size of the school to two form entry, this is about to happen. St. Joseph's is an Outstanding School and we are always oversubscribed. We have to turn away Catholics and non-Catholics every year which is distressing

for the families involved. With this increase in the size of the school, we will be able to accommodate more children and families. We are very aware that thousands of houses are about to be built in Bishop's Stortford and that the demand for places at St. Joseph's Catholic Primary will increase with new families moving into the area. We hope that the community will support this application as it will help the town overall".

Consultation on the proposal to enlarge the premises of St Joseph's Catholic Primary School, Great Hadham Road, Bishop's Stortford, Hertfordshire, CM23 2NL

We are consulting you on the following proposal:

The enlargement of the premises of St Joseph's Catholic Primary School, Great Hadham Road, Bishop's Stortford, Hertfordshire, CM23 2NL by 15 places (0.5 form of entry¹) from September 2018.

The proposal will support a permanent increase in the size of this school by 15 places (0.5 form of entry). This means the school will then have the capacity to admit 60 reception aged children in September 2018 and in each subsequent year thereafter, growing to a full 2 form entry (f. e.) school (with 420 places available) by September 2024. The current capacity of the school is 315 and the eventual capacity will be 420 pupils (excluding Nursery pupils).

St Joseph's Catholic Primary School has been successful in its bid, as part of the Government's Priority School Building Programme Phase 2 (PSBP2), which means significant works to improve the school built environment. As part of the planning for these works we have been in discussions with the school and the Diocese of Westminster around expanding the school to 2 f. e. which would assist in meeting a local Catholic need.

Why is this being proposed?

Analysis of recent applications for primary school places in Bishop's Stortford indicates an unsatisfied demand for Catholic provision in the town.

¹ One form of entry is 30 pupils per year group

The planned PSBP2 building scheme at St Joseph's Catholic Primary School offers the opportunity to consider the potential enlargement of the school which is likely to offer a value for money solution for 0.5 f.e. of additional places.

The county council considers it important to ensure that there are sufficient places available for very young children as near as possible to their homes. There is more information on how we plan **to meet the demand for school places** and our methods for forecasting at www.hertfordshire.gov.uk/schoolplaces.

The position in Bishop's Stortford

The total number of permanent reception places available in Bishop's Stortford is 480. In 2016/17, an additional 30 places were offered on a temporary basis to ensure every child was able to access a local reception place.

The following table shows the forecast demand for places and the surplus or shortfall based on the current number of permanent reception places available.

Although forecasts indicate a surplus of places from 2017/18 onwards, for the last three years the county council has had to add an additional 30 temporary reception places at local primary schools each year to meet actual demand. Alongside this the county council has implemented strategies to manage in-year demand where, in a number of primary year groups, there are no vacancies available across the whole town which means new families moving into Bishops Stortford with primary aged children potentially left without access to a primary school place into the town.

The county council is planning new primary schools to serve the proposed new housing development at Bishops Stortford North which will be located in the heart of the development and will be established in line with the developer's programme of house building. However, we are aware of other new housing proposed in Bishop's Stortford, which isn't taken account of in terms of additional primary provision proposed within the Bishop's Stortford North development. This new housing growth will further increase demand for school places across the town.

In order to ensure that the existing demand can be met locally and in light of the anticipated future housing growth, an additional 0.5 f. e. in the town would be helpful in meeting local need, could avoid the need for further temporary expansions and also potentially assist in meeting future in-year demand. Thus the county council is proposing to permanently increase the number of reception places available at St Joseph's Catholic Primary School from 45 to 60 from September 2018.

Why this school has been chosen for enlargement

The proposal to enlarge this school has been assessed against, and is considered to meet, the County Council's *Four Tests*. These are:

- Does it provide the right number of places in the right location?
- Does it support and not undermine school effectiveness?
- Are the implications for buildings, environment and cost, feasible and affordable?
- What are the transitional implications?

St Joseph's Catholic Primary School has been selected as it is located close to the area of demand and will assist in meeting a demand for catholic primary places which has been evidenced by recent application/allocation data. Initial feasibility work concludes that the site is capable of accommodating an enlargement, subject to further design work and town planning permission. An increase of 0.5 f. e. will mean the school becoming 2 f. e. permanently which is the county council's preferred size, offering a broad curriculum and enhanced opportunities for staff development. The proposed enlargement will provide the opportunity for pupils to be taught in straight year groups.

The alterations required for enlargement

The PSBP2 scheme is being managed by the Education Funding Agency (EFA) on behalf of the Government. If the county council makes a decision to enlarge this school, we would work to ensure that the additional accommodation supports pupils' needs whilst also ensuring that good value for money is achieved in the context of restrictions on public sector finance.

Planning permission will be required for any building work which would mean that the EFA would progress a town planning application. There would then be a separate consultation locally through the town planning system on the details of any proposed building work. Any specific town planning matters associated with this school site would need to be addressed as part of the planning application, including highways, parking and conservation issues.
