

HALF FARE BUS TRAVEL FOR 11 TO 19 YEAR OLDS

If you are aged 11 to 19 and travel by bus in Hertfordshire then you may qualify for reduced bus fares with a Hertfordshire SaverCard. All applicants must be resident in the administrative county of Hertfordshire.

A Hertfordshire SaverCard entitles you to travel for half the adult fare at all times on local bus services (except Transport for London services) within Hertfordshire and to certain destinations outside the county (see Conditions of Use). If you are aged 11 or above you must have a valid Hertfordshire SaverCard with you at the time of travel otherwise you will be charged the full adult fare. If you travel on Transport for London services you can travel free or at a discounted rate with a Zip Oyster photocard. Further information can be obtained from www.tfl.gov.uk

DO YOU QUALIFY?

If you are aged 11-19, and resident in the administrative county of Hertfordshire you can apply for a Hertfordshire SaverCard that will be valid for one year from the date of issue.

This can be renewed every year as long as you still qualify and renewals can be made up to 60 days before the date of expiry. There is currently a charge of £20 per paper application, per year. The price will increase by £5 on the 1st September 2019, making the cost of the SaverCard £25. If you apply online you can save £5 on the cost.

Applications will be regularly checked to ensure the eligibility criteria are met. If applications are found to be false then eligibility will be withdrawn permanently.

LOW INCOME SUPPORT

If your family is on a low income you may qualify for one Hertfordshire SaverCard free of charge each year. These applications must be made through the 'How can we help?' team. Please telephone **0300 123 4048** for further information.

HOW TO APPLY FOR YOUR HERTFORDSHIRE SAVERCARD

Please make sure that you are eligible to apply for a Hertfordshire SaverCard. The requirements are related to your age at the time of application.

If you meet the following condition:

- ✓ Aged 11 to 19 years

You can apply for a Hertfordshire SaverCard that will be valid for one year. You need to complete sections **A, B or C, D and E** of the application or alternatively you can apply on-line at: www.hertfordshire.gov.uk/savercard2019 and receive a £5 discount.

If you meet the following conditions:

- ✓ Resident in the administrative county of Hertfordshire.

You can apply for a Hertfordshire SaverCard that will be valid for one year. You need to complete sections **A, B or C, D and E** of the application form, affix your recent photograph and attach a cheque or postal order.

Please make sure that you send us everything that you need to make your application. Check now or your application may be delayed.

Please allow 14 WORKING DAYS for delivery.

Don't forget to complete sections A, B or C, D and E. Also enclose your cheque and photo.

After this time you can telephone 0300 123 4050 to find out what has happened to your application.

CONDITIONS OF USE

- 1 Hertfordshire SaverCards are only issued to persons up to the age of 19 on the date of issue. Applicants aged between 11 and 19 must be a resident in the administrative county of Hertfordshire. A SaverCard cannot be issued before the 11th Birthday.
- 2 A Hertfordshire SaverCard is only valid for use by the person named on the card when the photograph is a true likeness of the holder.
- 3 A Hertfordshire SaverCard must be presented before purchasing a ticket in order to qualify for the concession.
- 4 A Hertfordshire SaverCard allows the holder to purchase single and return bus tickets at half the adult fare. The discount offered for season, area and multi journey tickets may be less and cost more than half the adult fare.
- 5 The reduced fare is available at all times on all local bus services (except Transport for London services) within Hertfordshire and up to the following points outside the county. Amersham (College and Railway Station), Aylesbury Bus Station, New Barnet Railway Station, Chesham Broadway, Dunstable Square, Edgware Bus Station, Enfield Town Centre, Harlow Bus Station, Harrow Bus Station, Luton Town Centre, Mount Vernon Hospital, Southgate Tube Station and Uxbridge Bus Station.
- 6 The operators conditions of carriage apply.
- 7 A Hertfordshire SaverCard is not valid if it is altered or defaced in any way.
- 8 A Hertfordshire SaverCard is only valid up to the date shown if it has been renewed annually.
- 9 A Hertfordshire SaverCard is NOT transferable.
- 10 Possession of a Hertfordshire SaverCard does not confer any rights upon the holder other than those of a fare paying passenger.
- 11 A Hertfordshire SaverCard remains the property of Hertfordshire County Council.
- 12 When a Hertfordshire SaverCard is identified as not being valid then the driver will retain the card.
- 13 Any breach of these conditions will result in the withdrawal of the Hertfordshire SaverCard and will render the holder liable to prosecution.
- 14 Hertfordshire County Council reserves the right to alter or withdraw the Hertfordshire SaverCard scheme at any time.
- 15 Please allow up to 14 days for application to be processed. After this time, call 0300 123 4050 for an update on your application.
